By submitting this form and making a deposit/payment, the applicant accepts and agrees to the terms and conditions stated below. "Rye Racquet Club", "RRC", "Club" may be used interchangeably here. Group Captains will be referred to as "Player", "Applicant" or "Group Captain".

DATES: Indoor seasonal courts are in session for 30 weeks, beginning September 11, 2025, and ending April 24, 2026. Seasonal courts are not in session on November 27-28, 2025, and December 22, 2025, to January 4, 2026. These dates are excluded from your contract.

COURT DEPOSIT: A deposit of \$500 per court hour (\$750 for 1.5 hours, \$1,000 for 2 hours) must accompany this application. No court will be reserved without a deposit. This deposit is refundable prior to June 1, 2025, **only** if the Club is able to resell the court for the same number of seasonal court hours. Deposits are not refundable after June 1, 2025. **The Group Captain must submit the deposit payment for the group.**

PAYMENT: The Group Captain is responsible for the collection and payment of all court fees. The Club will not accept court fee payments from individual group players. Seasonal court fees are due in full by September 1, 2025, and will be charged to the card on file. Credit cards on file must be current and active. Any credit card changes must be made prior to September 1st.

If you prefer to pay by check/cash, payment must be received prior to September 1st. If full payment is not received, management reserves the right to cancel this contract and retain the deposit.

GROUP PLAYERS: Group Captains act on behalf of the players of the seasonal court and are obligated to share the Club's terms and conditions with their players. Group Captains are also responsible for supplying the names, addresses, email addresses and cell numbers of all their group players. Reservations will NOT be processed with incomplete player information. Liability insurance requires the Club to have complete player information. A maximum of four (4) players are allowed to play on each court.

PRO INSTRUCTION: Payments for professional instruction are in addition to court fees, and made directly to your pro at the time of the lesson. A Signed Pro Agreement must be completed and submitted to the Club, online or along with your application.

*Only Rye Racquet Club pros are allowed to teach on the court.

*RRC reserves the right to modify the Signed Pro Agreement and to re-assign a Staff Pro if the selected Pro is unable to complete instruction for the season.

*Due to liability insurance, only six (6) balls are allowed on each court, unless playing with an RRC Pro.

MAKE-UPS/CANCELLATION: The Group Captain is responsible for notifying the Seasonal Court Coordinator and the Pro at least one (1) week in advance to be eligible for a makeup. Each court is eligible for two (2) makeups OR you may choose to resell the seasonal court. If resold, the equivalent of 75% of the resale amount will be credited to the account of the Group Captain.

***No-shows or last-minute cancellations are not eligible for makeups or a resale. Pro fees may be charged as compensation for the Pro's time.**

*Make-ups are subject to availability and must be used by the end of the Seasonal Court period.

CLOSURE: Notice of Club closure due to inclement weather or emergencies will be emailed, and posted on our website and social media. The Club does not follow school closings. Please call the Club with additional questions.

COURT ASSIGNMENT: The Club reserves the right to place a group on any available court. Seasonal courts may or may not have program/clinics/instruction on adjacent courts. The Club reserves the right to change Court Assignments during the season. The Group Captain will be notified of any changes.

COURT BEHAVIOR AND ETIQUETTE:

- Please wait until your assigned court time begins and leave promptly at the end.
- Only Seasonal Court players are allowed on the court.
- Respect and courtesy are expected among ALL players and towards RRC Pros/Employees.
- Foul language and aggression on the court and in the Club will NOT be tolerated. Players may be asked to leave the premises.
- Please dispose of your trash.
- ALL players are required to pick up balls prior to leaving.
- Cell phone use: Please keep your phone silent when on the courts. Please refrain from loud calls while in the lobby or locker room areas, and avoid talking about personal or confidential topics.

FOOD AND DRINK: All food and drinks are prohibited on the courts. **Only water in a covered container is allowed.**

PERSONAL PROPERTY: The Club is not responsible for valuables lost or stolen in the Club or parking lot.

TENNIS ATTIRE: Neat athletic attire and tennis sneakers ONLY. Sneakers must be non-marking and flat-soled.

PHOTO RELEASE: I hereby grant Rye Racquet Club permission to use my likeness and/or my child's likeness in a photograph, video, or other digital media, in any and all of its publications, including, but not limited to, web-based publications and social media, without payment or other consideration.

RISK OF INJURY/WAIVER OF CLAIMS: I declare myself and/or my minor child(ren) to be physically sound and suffering from no condition, impairment, disease, infirmity, or other illness that would prevent participation in the Club's programs or playing in the Club. The use of the facility is strictly at the player's risk. The Club is not responsible for injuries, exposure to infectious diseases, accidents or damages you may receive from activities or any interactions with other persons on the premises. In case of an accident or injury, and if an emergency contact person cannot be reached, I grant the Club permission to obtain medical attention for me and/or my minor child(ren), as the Club deems necessary, for which I will be financially responsible. All players and their guests further release the Club and its employees from all suits, claims or demands for damages arising from their use of this facility.

TERMINATION OF AGREEMENT: Players must follow all terms and conditions as stated here and as posted by the club. Failure to do so may result in the termination of this Seasonal Court Agreement. The Club reserves the right to terminate this agreement for other reasons considered necessary.

*In the event of a Pro re-assignment, the player may choose to terminate this agreement and request a refund. However, a refund to the Group Captain's account will only be applied IF and WHEN the said Seasonal Court is resold to another player.

*Player may terminate this agreement for the following reasons:

- 1) If upon a doctor's order you cannot physically receive the services because of a significant physical disability for a period in excess of six (6) months.
- 2) If you die, your estate shall be relieved of any further obligation for payment under the contract not then due and owing.
- 3) If you move your residence more than 25 miles from the Club.
- 4) If the services cease to be offered as stated in the contract.
